Government of Assam invites Expression of Interest from experienced and resourceful institutions to register their interest for establishment and running of a Medical College & Hospital in the district of Nagaon, Assam in PPP mode. It is proposed to utilize the existing facilities of B.P. Civil Hospital, Nagaon which is a 190 bed Civil Hospital and land for the College would be provided by the Government at its own cost in a suitable place in accordance with the requirements prescribed by the Medical Council of India.

The agreement for setting up the Medical College would initially be valid for a minimum period of thirty years, extendable further through mutual consent.
